FXPI ANATORY NOTES ON SPECIAL BUSINESS

Dato' Ab Halim bin Mohyiddin ("Dato' Ab Halim") was appointed as an Independent Non-Executive Director on 14 June 2003 and was subsequently designated as a Senior Independent Non-Executive Director on 29 June 2011. Thereafter, he was re-designated as Chairman of the Company on 29 April 2013. Although he has exceeded the maximum tenure of nine (9) years as an Independent Director as prescribed by the MCCG 2012, the Nomination Committee and the Board of Directors ("the Board"), after having assessed the independence of Dato' Ab Halim, considers him to be independent based on the following justifications and recommends that Dato' Ab Halim be retained as an Independent Non-Executive Director of the Company in respect of Ordinary Resolution 5:(a) He has confirmed and declared that he is an Independent Non-Executive Director as defined under Paragraph 1.01 of Bursa Malaysia Securities Berhad's Main Market

He has commend and declared that he is an independent Non-Executive Director as defined under Paragraph 1.01 or bursa manaysia Securities Bernad's main market Listing Requirements;
He is not related to any of the Company's directors or major shareholders;
He does not have any conflict of interest with the Company and has not entered/is not expected to enter into contract(s) especially material contract(s) with the Company and/or its subsidiary companies;
He is currently not sitting on the board of any other public and/or private companies having the same nature of business as that of the Company and its subsidiary companies;

and this experience and knowledge of the Company and the Group's activities and corporate history is invaluable to the Board. The Board is also of the view that his impartial opir and advice in his role as the Company's Chairman and Chairman of the Company's Audit and Nomination Committees will be beneficial to the Board and the Company too
